

# **GIVING FROM AN IRA**

Each IRA owner, age 70  $\frac{1}{2}$  or over, can make **tax-free gifts** directly from his or her IRA to InterVarsity and other charities with a Qualified Charitable Distribution (QCD).

#### **Benefits**

- QCDs are excluded from taxable income (therefore offer the same benefits as an itemized income tax charitable deduction).
- If you are taking Required Minimum Distributions (RMDs), QCDs can count toward satisfying your RMD without increasing your taxable income.
- Your gift supports the important work of InterVarsity with a tax-free gift.

## How to Make a Qualified Charitable Distribution to InterVarsity

- Contact your IRA custodian/administrator for their procedures. Tell them you
  want to initiate a Qualified Charitable Distribution directly to

#### Important Tax Considerations When Making a Qualified Charitable Distribution

- For tax purposes, the date of your gift is the date the funds **leave your IRA** account:
  - o Fund Transfers must be completed on or before December 31
  - o **Checks** should be mailed to InterVarsity by early December, to allow time for them to be received, deposited and clear your account by December 31.
- If you are 70 ½ or older, still working, and are making deductible contributions to your IRA, check with your tax advisor before making a QCD.
